FAMILY PROMISE OF BREVARD IS COMMITTED TO ENDING FAMILY HOMELESSNESS IN BREVARD BY COLLABORATING WITH OUR COMMUNITY TO PROVIDE FAMILIES THE SUPPORT AND RESOURCES THEY NEED TO PUT THEMSELVES ON A PATH TOWARDS LONG-TERM HOUSING STABILITY. IN 2019, WE PROVIDED DIRECT SERVICES FOR 501 UNIQUE INDIVIDUALS, 62% OF THEM CHILDREN, THROUGH OUR EMERGENCY SHELTER, HOUSING STABILIZATION, AND HOMELESS PREVENTION PROGRAMS. WITH THE SUPPORT OF 31 CONGREGATIONS AND OVER 900 VOLUNTEERS, WE HAVE PROVIDED OVER 18,000 BED NIGHTS AND 166,000 MEALS TO FAMILIES EXPERIENCING HOMELESSNESS. THEIR SUPPORT, PAIRED WITH OUR INTENSIVE CASE MANAGEMENT, HAS MOVED 87% OF OUR FAMILIES INTO HOUSING WITHIN AN AVERAGE OF 36 DAYS. ADDITIONALLY, 90% OF THE FAMILIES WHO STAY IN AFTERCARE STABILIZATION FOR A YEAR AFTER SHELTER REMAIN HOUSED. OUR HOMELESS PREVENTION PROGRAM HAS PREVENTED/DIVERTED OVER 2,000 HOUSEHOLDS FROM HOMELESSNESS SINCE 2017, WITH AN AVERAGE FINANCIAL INTERVENTION OF LESS THAN 300/CHILD.
